HARKESH MANUJA, J.(Oral)

1. By way of present petition filed under Section 482 Cr.P.C., prayer has been made for quashing the order dated 19.03.2024 (Annexure P-3), whereby while passing order of suspension of sentence and release of the petitioner, subject to furnishing of his bail bonds and surety bonds, he was directed to deposit 20% of the compensation amount within a period of 60 days.
2. Learned counsel for the petitioner submits that the petitioner happens to be a poor man and he does not have the financial capacity to deposit 20% of the compensation amount.

Learned counsel while relying upon decision made by the Hon’ble Supreme Court in “Jamboo Bhandari vs. M.P. State Industrial Development Corporation Ltd. and others”, 2023(10)SCC 446, submits that in exceptional circumstances, the deposit as contemplated under Section 148 of the Negotiable Instruments Act, 1881 can be reduced. Relevant para

7 of the ***Jamboo Bhandari's*** case (supra) is reproduced as under:-

“7. Therefore, when Appellate Court considers the prayer under Section 389 of the Cr.P.C. of an accused who has been convicted for offence under Section 138 of the N.I. Act, it is always open for the Appellate Court to consider whether it is an exceptional case which warrants grant of suspension of sentence without imposing the condition of deposit of 20% of the fine/compensation amount. As stated earlier, if the Appellate Court comes to the conclusion that it is an exceptional case, the reasons for coming to the said conclusion must be recorded.”

3. Having heard learned counsel for the petitioner and considering the facts and circumstances of the present case, the order dated 19.03.2024 is modified to the extent that the petitioner shall deposit Rs.5,000/- towards the amount of compensation before the First Appellate Court within a period of 04 weeks from today. As regards the remaining amount towards compensation, the petitioner shall be at liberty to approach the first Appellate Court pointing out his exceptional case in his favour and the same shall be considered and decided by the concerned Court while considering the exposition of law laid down in ***Jamboo Bhandari's*** case (supra).

4. Accordingly, the petition stands disposed of.
