SUMEET GOEL, J.

1. By way of present petition, the petitioner is seeking quashing of FIR No.80 dated 25.06.2022 under Sections 406, 498-A of IPC, registered at Police Station, Sadar Gurdaspur, District Gurdaspur (Punjab) and all consequential proceedings arising therefrom on the basis of compromise, which is stated to have been effected between the parties.

2 On 15.02.2024, the following order was passed:

“Mr. Manoj Kumar Sharma, Advocate has appeared and filed power of attorney on behalf of respondent No.2. The same is taken on record.

The parties are directed to get their statements recorded qua the factum of compromise in the following manner:

(i) The petitioner shall appear before the trial Court/Illaqa Magistrate concerned on 20.02.2024 or any date thereafter as fixed by trial Court/Illaqa Magistrate for recording statements of the petitioner as well as of the complainant qua the factum of compromise. As and when any such appearance is made, the trial Court/Illaqa Magistrate shall do the needful for recording the statements of the parties qua the factum of the compromise. It shall be open to the trial Court/Illaqa Magistrate to either record the statements of the parties by physical process or by video

conferencing as deemed appropriate by the trial Court/Illaq Magistrate.

(ii) In case the statement is to be recorded by way of video conferencing, the parties concerned shall be duly identified through video conferencing by their respective counsel, subject to the satisfaction of the Presiding Officer.

(iii) The trial Court/Illaq Magistrate may also choose to get the statements of the parties recorded through some Commissioner, appointed by the Court who would be some Advocate having sufficient standing at the Bar. In case the statement is recorded through some Commissioner, such Commissioner/Advocate shall furnish an affidavit after recording statements to the effect that the parties had appeared before him/her and he/she had recorded their statements as per law and that the said parties had been duly identified by their respective counsel. This shall be subject to satisfaction of trial Court/Illaq Magistrate.

After recording the statements of all the affected parties in either of the aforesaid manner, the trial Court/Illaq Magistrate shall submit its report on the basis of the statements so recorded as to whether all the affected parties have entered into a compromise and as to whether the compromise in question is found to be a valid compromise and has been effected without there being any kind of influence or coercion.

The trial Court/Illaq Magistrate shall also report as regards the following facts after seeking information from Investigating Officer, concerned:

(i) Whether there is any other accused other than the petitioners, arrayed in this petition?

(ii) Whether there is any other complainant or affected/ aggrieved party other than the respondents, arrayed in the petition?

(iii) Whether any accused has been declared Proclaimed Offender?

The report be submitted before this Court before the next date of hearing i.e. 12.03.2024."

3. Pursuant to the aforesaid order, report dated 01.03.2024 from Additional Chief Judicial Magistrate, Gurdaspur, has been received, which is taken on record. As per the report, the Trial Court has recorded as follows:-

"In reference to subject cited, I have the honour to submit that vide order bearing No. CRM-M-21303 of 2023, dated 15.02.2024, passed by Hon'ble High Court in case titled as "Balwinder Singh Versus State of Punjab and another", Hon'ble High Court was pleased to direct the Trial Court/Illaq Magistrate to record statements of parties regarding genuineness of the compromise. Keeping in view of the spirit of order aforementioned, statements of petitioner namely Balwinder Singh son of Mukhtiar Singh, aged about 31 years, resident of Village Thali Khurd, District Rupnagar (Punjab) as well as respondent no.2/complainant Kulwant Kaur wife of Balwinder Singh and daughter of Sulakhan Singh, aged about 26 years, resident of Village Lakhawal, District Gurdaspur

were recorded. The petitioner aforementioned has stated that FIR No.80, dated 25.06.2022, registered against him under Sections 406, 498-A of IPC, Police Station, Sadar Gurdaspur, at the instance of complainant/respondent No.2 Kulwant Kaur aforesaid and the matter had been amicably resolved between them with the intervention of respectables of the society and the said compromise was without any undue influence, coercion or pressure of any kind and he has prayed that said FIR may please be quashed against him. Respondent no.2/complainant Kulwant Kaur has also suffered separate statement to the effect that present FIR No.80, dated 25.06.2022, registered by her under Sections 406, 498-A of IPC, Police Station, Sadar Gurdaspur against the petitioner afore- mentioned and stated that matter has been compromised between them and also stated that the compromise was voluntary, genuine and was free from any pressure or coercion in any manner. She has stated that she has no objection, if the present FIR is quashed against above-mentioned petitioner/accused, Statement of I.O/ASI Sohan Lal has also been recorded, wherein he has stated that he is Investigating Officer of the present case and this case was got registered by complainant/respondent No.2 Kulwant Kaur afore-said. There is only one accused namely Balwinder Singh son of Mukhtiar Singh, aged about 31 years, resident of Village Thali Khurd, District Rupnagar (Punjab). There is only one complainant/respondent no.2 Kulwant Kaur. There is another case under Section 13-B of Hindu Marriage Act pending between the parties before the Court of learned Principal Judge, Family Court, Gurdaspur and the next date of hearing in the said petition is 04.03.2024. Accused has not been declared Proclaimed Offender in this case, till date. The challan against accused has not been presented in Court.”

4. Learned counsel for respondent No.2 admits the factum of parties having compromised and states that he has no objection in case the FIR and all proceedings subsequent thereto against the petitioner are quashed.

5. Similarly, learned State counsel has stated that he has no objection in case the FIR is quashed based upon the compromise.

6. I have heard learned Counsel for the parties and have carefully gone through the records of the case.

7. This Court and the Hon'ble Apex Court has repeatedly dealt with the issue of exercise of jurisdiction under Section 482 of the Code to quash proceeding in non-compoundable offences in the cases of ***Gian Singh vs. State of Punjab and another, 2012(10) SCC 303, Kulwinder Singh & others vs. State of Punjab & another, 2007 (3) RCR (Criminal) 1052 and Ram Gopal and another vs. State of Madhya Pradesh, 2021(4) R.C.R. (Criminal) 322 (Criminal Appeal No.1489 of 2012 decided on 29th of September, 2021)***. The proposition of law that emerges from the aforesaid decisions rendered by the Hon'ble Apex Court and this Court is :

- (a) *Power u/s 482 Cr.P.C. vested with this Court is much wider and is unaffected by Section 320 of the Code.*
- (b) *However, wider the power greater the caution.*
- (c) *The underlining principle while exercising such power is that it can be invoked to quash the proceedings recognizing compromise between the parties in the matters which are overwhelmingly and predominantly of civil character like commercial transactions or arising out of matrimonial relationship or family disputes.*
- (d) *The said power is not to be exercised in the prosecutions involving heinous and serious offences of mental depravity or offences like murder, rape, dacoity etc. as such offences are not private in nature and have a serious impact on society.*
- (e) *Section 482 Cr.P.C. casts duty upon the High Court to advance interest of justice as well. It is in recognition of this duty casted upon the High Court, that Apex Court held that the High Court would not refuse to quash FIR under Section 307 merely because FIR finds mention thereof. High Court can assess nature of injuries sustained, whether such injuries inflicted on vital/delicate parts of the body/nature of weapons used etc.*
- (f) *Such exercise at the hands of High Court would be permissible only after the evidence is collected after investigation and chargesheet is filed/charges framed during the trial. Such exercise cannot be carried out while the matter is still under investigation.*
- (g) *While quashing FIR in non-compoundable offences even which are of private in nature, High Court is required to consider*

antecedents of the accused, conduct of the accused and whether he was absconding or whether he has managed the complainant to enter into a compromise.

8. Thus, keeping in view the aforesaid facts and circumstances, this Court is of the considered opinion that it is a fit case to exercise jurisdiction vested u/s 482 Cr.P.C. to quash the FIR as :-

- (i) Putting a quietus to the proceedings will bring peace and tranquility amongst parties & will accordingly further the cause of substantial justice.*
- (ii) The offences alleged are primarily of private nature.*
- (iii) The parties have compromised.*
- (iv) As per the report received the compromise is said to be voluntary in its nature.*
- (v) Complainant/victim is reported to have entered into compromise on his own volition*

9. Consequently, the petition is allowed. FIR No.80 dated 25.06.2022 under Sections 406, 498-A of IPC, registered at Police Station, Sadar Gurdaspur, District Gurdaspur (Punjab) and all consequential proceedings arising therefrom on the basis of compromise, are, hereby, quashed qua the petitioner.
