[1] The present petition has been filed under Section 482 of the Code of Criminal Procedure, 1973 for quashing of FIR No.8 dated 14.04.2021, under Sections 406 and 498-A IPC registered at Police Station Women, Phase-8, District SAS Nagar (Annexure P-1), on the basis of compromise executed between the parties vide order dated 19.04.2024 passed by this Court in CRM-M-38201 of 2021 titled *Gaurav Kashyap vs. State of Punjab* (Annexure P-2).

[2] Learned counsel for the petitioner contends that the FIR was registered at the instance of respondent No.2 on account of a matrimonial dispute between the petitioner and respondent No.2. He further contends that the matter

has been settled between the parties and compromise has been executed between them vide order dated 19.04.2024 passed by this Court in *CRM-M-38201 of 2021* titled *Gaurav Kashyap vs. State of Punjab* (Annexure P-2). He submits that the matter stands settled between the parties, as such, respondent No.2 does not want to take any action in the FIR.

[3] Learned counsel for respondent No.2 confirms about the factum of compromise between the parties.

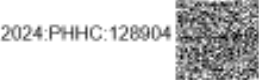
[4] Learned State counsel has not raised any objection regarding the acceptance of the present petition.

[5] The matrimonial dispute between the parties stands resolved. In view of the above, no useful purpose would be served to continue with the prosecution of the petitioners in the present FIR.

[6] Keeping in view the fact that the compromise between the parties is genuine and voluntarily made and in view of the ratio of the decision of Hon'ble Apex Court in ***Gian Singh Versus State of Punjab (SC) 2012 (4) RCR (Criminal) 543*** and the decision of Hon'ble the Full Bench of this Court in ***Kulwinder Singh and others vs. State of Punjab and others 2007 (3) RCR (Criminal) 1052***, the ends of justice would meet if the FIR and consequential proceedings are quashed by accepting the compromise between the parties.

[7] Consequently, this petition is allowed and FIR No.8 dated 14.04.2021, under Sections 406 and 498-A IPC registered at Police Station Women, Phase-8, District SAS Nagar (Annexure P-1) and all the subsequent proceedings emanating therefrom are ordered to be quashed, qua the petitioner.

[8] However, the respondent No.2 and the State shall be at liberty to seek cancellation of this order, in case the final terms and conditions of compromise



(Annexure P-2) are violated.

[9] Pending miscellaneous application(s), if any, shall also stand disposed of.
