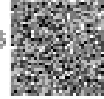

KULDEEP TIWARI. J.(Oral)

1. Through this second petition, the petitioner has sought the interim of interim regular bail for a period of 8 weeks, in case FIR No.146 dated 09.09.2022, under Sections 302, 307, 336, 447, 120-B, 148, 149 of the IPC, and under Sections 25 and 27 of the Arms Act (under Sections 54, 59 and 29 of the Arms Act added subsequently), registered at Police Station Mallanwala, District Ferozepur, Punjab.

2. Earlier the petitioner has approached this Court for grant of regular bail, which was dismissed as withdrawn on 16.04.2024, by this Court. Thereafter, the petitioner suffered a fall at Central Jail Ferozepur, and he suffered internal injuries on his back, which caused impediment to the petitioner, to take care of himself, as he cannot move properly.

3. On asking for the relief of grant of regular bail to the petitioner, learned counsel for the petitioner submits that since the day of fall, the petitioner

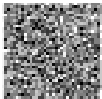
is confined in the hospital of Central Jail, Ferozepur.

4. Upon notice, short affidavit dated 12.05.2024 of Sh. Satnam Singh, Central Jail, Ferozepur has been filed on behalf of respondent-State. The same is taken on record.

5. Medical status report dated 12.05.2024 of the petitioner, issued by the Medical Officer, Central Jail, Ferozepur has also been filed on behalf of respondent-State. The same is taken on record. The relevant part of the medical report reads as under:-

"As per Jail medical record Kabal Singh Son Hari Singh had an alleged history of fall at Central Jail. Patient was sent for treatment at Civil Hospital Ferozepur on 23-04-2024. Where Xray spine, Xray coccyx, Xray PBH was performed and following treatment was given by the orthopedician:- Taylor brace, Tab. etoricox TH, Tab. pregablin 75 mg, Tab calcium and Tab. cissjod M. He was also advised NCCT spine, avoiding forward bending, avoiding sitting on the floor, avoiding cross legs. Most recently on 09-05-2024 he was again sent for follow up at Civil Hospital Ferozepur, ortho OPD. He was given treatment Inj. nandrolone, Inj. vovran, Tab. etoricox TH, Tab. pragablin 75 mg, Tab calcium, Tab. Vitamin D-3, Vitamin-C, Vitamin-E. He was also advised hot formentation on daily basis. He will be again sent for follow up for NCCT LS spine on next date for further treatment. Currently Patient is complying to treatment and is kept under observation at Central Jail Ferozepur. The patient is admitted in Jail Hospital and currently is in stable condition."

6. A perusal of the above status report reveals that the petitioner is confined at Central Jail Ferozepur, and the petitioner was advised for NCCT LS spine, avoiding forward bending, avoiding sitting on the floor, avoiding cross legs,



and is kept under observation at Central Jail Ferozepur.

7. Considering the medical status report of the petitioner, and the fact that the petitioner is not involved in any other case, and has suffered incarceration of 01 year, 08 months and 01 day, as of today, this Court deems it fit and appropriate to enlarge the petitioner on interim regular bail for a period of 04 weeks.

8. The petitioner shall be released on furnishing of requisite bail bonds and surety bonds, subject to the satisfaction of the learned Chief Judicial Magistrate/Illaq Magistrate/trial Court concerned, and he shall re-step into the prison on 10.06.2024, at 5:00 PM in the evening.

9. It is made clear that in case the petitioner fails to re-step into the prison on 10.06.2024, at 5:00 PM in the evening, the Station House Officer concerned, shall forthwith arrest the petitioner, and produce him before the learned trial Court concerned, and the thereafter, the latter shall take appropriate action in the said regard, in accordance with law.

10. The instant petition stands **disposed** of accordingly.
