In the present petitions, challenge is to the order passed by the respondents on the representation filed by the petitioners claiming certain relief by which, the said relief has been declined.

Learned counsel for the petitioners submits that the representation was filed keeping in view the order passed by this Court dated 14.10.2020 but neither the said order nor the averments made in the representation filed qua certain facts mentioned therein have been taken into account by the respondents while passing order on the representation of the petitioners and totally a cryptic and non-speaking order has been passed by the respondents, which is liable to be set aside being contemptuous in nature as the direction given by this Court has not been complied with.

Faced with this situation, learned counsel for the respondents submits that as per the instructions received by him from Ms. Harkirat Kaur, Director School Education (Elementary) Punjab, orders impugned in the present petitions passed on the representations of the petitioners be treated as withdrawn with liberty to the respondents to pass a fresh speaking order in accordance with law on the representation filed by the petitioners so that a detailed speaking order could be passed dealing with all the contentions

raised therein so as to decide the claim raised, which speaking order will be passed within a period of 08 weeks from the date of receipt of copy of this order.

Learned counsel for the petitioners submits that keeping in view the statement made by learned counsel for the respondents, present petitions may kindly be disposed of having been not pressed any further.

Ordered accordingly.
