The instant petition has been instituted under Articles 226/227 of the Constitution of India, 1950 seeking issuance of a writ in the nature of Mandamus directing the respondents to release the due payment of Rs. 18,20,984/- qua the works executed by the petitioner, alongwith interest @ 12% per annum.

Learned counsel for the petitioner contends that the petitioner had executed various works assigned to him from time to time and there has never been any complaint against the works executed by the petitioner. On 30.06.2023, certain works were allotted to the petitioner and the same have been successfully completed by the petitioner within prescribed time limit. The first and final bills of the aforesaid works have been duly passed but its payment has not been released till date. The details of these works and the

amount payable to the petitioner are mentioned in para No.2 of the writ petition. The petitioner approached the respondents a number of times and submitted numerous representations. However, nothing fruitful could be fetched. Lastly, a Legal Notice dated 05.04.2024 (Annexure P-3) has been served by the petitioner upon respondent No.5-the Executive Engineer, Construction Division PWD B & R Branch, DAC, Chenab-Jehlam, Moga to release the aforesaid amount but till date due amount has not been released to the petitioner.

Notice of motion.

Ms. Akshita Chauhan, DAG, Punjab appears and accepts notice on behalf of respondents.

Learned counsel for the petitioner, however, submits that at this juncture, he would be satisfied if respondent No.5-the Executive Engineer, Construction Division PWD B & R Branch, DAC, Chenab-Jehlam, Moga is directed to consider and decide the Legal Notice dated 05.04.2024 (Annexure P-3) in a time bound manner.

Learned counsel for the respondents does not oppose the prayer made by learned counsel for the petitioner.

Accordingly, in view of the above, with the consent of the parties and without commenting anything on the merits of the case, the present petition is disposed of while directing respondent No.5-the Executive Engineer, Construction Division PWD B & R Branch, DAC, Chenab-Jehlam,

Moga to consider and decide the Legal Notice dated 05.04.2024 (Annexure P-3) by passing a reasoned and speaking order after affording an opportunity of hearing to the respective parties within a period of three months from the date of receipt of certified copy of this order.

Needless to mention that upon considering the said Legal Notice, if any amount is found due and payable to the petitioner, the same shall be disbursed in his favour within a further period of three months.

Petition stands disposed of accordingly.
