This petition has been filed under Section 438 Cr.P.C. seeking anticipatory bail in a case bearing FIR No.17 dated 17.02.2023 under Sections 307/452/323/324/506/148/149 of IPC registered at Police Station Bhogpur, District Jalandhar.

On 29.05.2023, the following order was passed:-

1. *'Jaskirat Singh and Harmeet Kaur @ Harjit Kaur-petitioners are seeking anticipatory bail in case FIR No.17 dated 17.02.2023 registered under Sections 307/452/323/324/506/148/149 IPC at Police Station Bhogpur, District Jalandhar.*
2. *Status report by way of affidavit of Sukhnaaz Singh, PPS, Deputy Superintendent of Police, Sub Division, Adampur, Jalandhar (Rural) on behalf of the respondent-State in CRM-M-22184-2023 has been filed and the same is taken on record.*
3. *Learned counsel for the petitioner(s) contend that Jaskirat Singh petitioner was not a member of*

unlawful assembly which had inflicted injuries on the person of the injured. The only allegation against him is to the effect that he had supplied the weapons to Gurwinder Singh, the co-accused and others by means whereof injuries were inflicted. Two of the co-accused, namely, Muskanjit Kaur has been granted regular bail and Sehajpal Singh has been granted bail on the basis of being a juvenile. Moreover, there is a delay of 06 days in lodging the FIR. Although, the injury under Section 307 IPC has been attributed on the person of 11 years old young boy but he has been discharged from hospital and is enjoying good health. It has been further submitted that the injury under Section 307 IPC has not been attributed to either of the petitioners.

The allegations against Harmeet Kaur @ Harjit Kaur-petitioner are to the effect that she was armed with stone and had inflicted injuries on the person of Harjit Singh-complainant on his right arm.

4. Adjourned to 27.09.2023.

5. Meanwhile, it is directed that in the event of arrest, the petitioners be admitted on interim bail on furnishing bail bonds to the satisfaction of the Arresting Officer subject to the condition that they joins the investigation and comply with other conditions as specified under Section 438(2) Cr.P.C.

6. Photocopy of this order be placed on the file of other connected case. '

Learned State counsel on instructions from ASI Kabal Singh, at the very outset informs the Court that the petitioner has joined the investigation and his custodial interrogation is not required.

In view of the statement of learned State counsel, order dated
