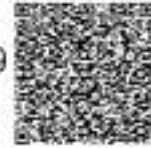

MAIN CASE

Present writ petition has been filed under Article 226 of the Constitution, *inter alia*, for quashing of the impugned office order dated 25.02.2022, issued vide Endst. dated 14.03.2022 (P-6) as issued by respondent No.1 and consequent order dated 25.05.2022 (P-14), whereby posting of petitioner with Bhakra Beas Management Board at Slappar in District Sundernagar, Himachal Pradesh at a distance of more than 300 Kms. upon his promotion as Sub Divisional Officer in Handicapped quota (60% permanent disabled) vide office order dated 15.12.2021 (P-2).

(2) Challenge was made to the transfer order dated 25.05.2022, which had been stayed by this Court on 02.06.2022; but petitioner stood retired w.e.f. 30.06.2024; thus, as on today, nothing survives in the present writ petition for adjudication.

(3) In view of the above, this petition is disposed off as having been rendered infructuous.

Pending application(s), if any, shall also stand disposed off.
