Present petition has been filed under Section 482 Cr.P.C. praying for quashing of FIR No.297 dated 06.11.2017, under Section 447 read with Section 511, Sections 506, 148 read with Section 149 of the Indian Penal Code, 1860, registered at Police Station Daba, District Ludhiana, along with all consequential proceedings arising therefrom.

2. At the very outset, learned State counsel has produced a copy of order dated 10.07.2021 along with statement of the complainant dated 09.07.2021 recorded by the Presiding Officer, National Lok Adalat, Ludhiana, which are taken on record as Mark 'X' (colly.).

3. For reference, aforesaid statement as well as the order read as under:-
