Present civil writ petition has been filed under Articles 226/227 of the Constitution of India seeking issuance of direction in the nature of mandamus, directing the official respondents to enter and sanction the mutation of land measuring 7 kanal 12 marla from the Khata/Khatoni No.277/601, Khasra No.1996, 1997 min out of total land measuring 19 Kanal being shareholder to the extent of 52/330 as per the jamabandi of 1993-94, situated at village Balloh, District Bathinda, in the name of the petitioners as per the registered transfer deed dated 28.01.1999 (Annexure P-2), keeping in view the fact that the plot of petitioner measuring 15 ½ biswa, situated at Bathinda has already been transferred in the name of respondent No.5 as per the transfer deed dated 28.01.1999, in lieu of aforesaid land measuring 07 kanal and 12 marlas. Further prayer has been made for directing the official respondents to decide the application/representation dated 06.02.2018 (Annexure P-5) in a time bound manner and to sanction & enter the mutation in the name of petitioners.

Learned counsel for the petitioners submits that for the redressal of their grievances, petitioners have filed a representation dated 06.02.2018 (Annexure P-5) before respondent No.2 i.e. The Naib Tehsildar Ballian Wali, Tehsil Phul District Bathinda but the same has not been taken into consideration till date. He has further submitted that petitioners would be satisfied if representation dated 06.02.2018 (Annexure P-5) is decided in a time bound manner.

Notice of motion.

On the asking of the Court, Mr. Navneet Singh, Sr. D.A.G., Punjab, accepts notice on behalf of the official respondents-State.

Heard.

After hearing counsel for the parties, respondent No.2 i.e. The Naib Tehsildar Ballian Wali, Tehsil Phul District Bathinda is directed to decide the representation dated 06.02.2018 (Annexure P-5) filed by the petitioner expeditiously preferably within one month from today, in accordance with law.

In view of the above, present petition is disposed of.
