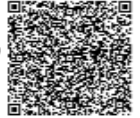
PANKAJ JAIN, J. (Oral)

1. Present petition has been filed under Section 439 Cr.P.C. for grant of regular bail to the petitioner in case bearing FIR No.171 dated 08.06.2023, registered for the offences punishable under Sections 307, 411 and 34 of IPC, 1860 and Sections 25 and 27 of Arms Act, 1959 at Police Station Sadar Amritsar, District Amritsar.

2. As per the contents thereof, it has been alleged as under:-

“Statement of Sukhdeep Singh alias Sukha son of Prem Singh resident of H. No. 89, street No. 03, Gumtala Colony, Loharka Road, Amritsar years, mobile No. about aged 95017-48054. I East 26 would like to state that I am resident of above noted address and I am running Saloon shop in Nangli Colony, Loharka road Amritsar which is near my village. Today at around 5.45/5.00 PM, I was coming from my saloon to my house on my motorcycle make Bullet bearing registration No.

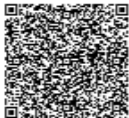
colour black and when I PB02-DY-1909 was turning towards my house from turning point of street from Loharka road then two youngmen came on a motorcycle from front side/Loharka road bypass side, name of person sitting on back seat of motorcycle, is Vicky alias Anda son of Kashmir Singh resident of Gumtala Colony West Loharka road Amritsar but I don't know about the name of driver of said motorcycle, who, in connivance to his associate, has made fire on me with his pistol with the aim to kill me and said fire hit on the engine of my motorcycle and he made another fire on me which has gone through above said of my head, then I thrown my motorcycle and ran away in the street. On looking the gathering of public, the above said both youngmen ran away from the spot on their motorcycle. The motive behind the incident is that earlier a small quarrel was occurred between me and Vicky Anda, due to which, he has tried to kill me by firing on me. Statement got recorded, heard same is correct.xxx”

3. Counsel for the petitioner contends that though the petitioner has been booked for offence punishable under Section 307 of IPC, however, it is a case of no injury. Challan already stands presented. By now, the petitioner has already suffered incarceration for more than 07 months and 03 days.

4. *Per contra*, State counsel however opposes the bail plea to submit that the petitioner is facing 03 more FIRs. However, he is not in a position to dispute the fact that it is a case of no injury.

5. Keeping in view the incarceration already suffered by the petitioner, the present petition is allowed. Petitioner is ordered to be

released on regular bail on his furnishing bail/surety bonds to the satisfaction of the Ld. Trial Court/Duty Magistrate, concerned.
