KULDEEP TIWARI, J. (Oral)

1. Through the instant petition filed under Section 439 Cr.P.C. the petitioner prays for grant of regular bail in case FIR No.31 dated 15.3.2024, under Sections 308/379-B/323/506/148/149 IPC (Sections 325 and 411 IPC added lateron), registered at Police Station Kotbhai, District Shri Muktsar Sahib.

2. The gist of the allegations against the petitioner, which have been culled out by the learned Sessions Judge, Sri Muktsar Sahib, reads as under:-

“The present case has been registered at the instance of Yudhveer Singh @ Yodha on the allegations that 14.3.2024, he was getting repaired his tractor bearing registration no.PB-13-1493 make Shivraj at the shop of Mander Singh Chhateana. At about 2:00 PM, Kali Singh armed with baseball bat, Rajpreet Singh alias Mana alias Channi armed with baseball bat, Krishan Singh armed with baseball bat, Labh Heera armed with wooden

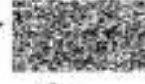

Sota, Jagmeet Singh armed with wooden Sota, Bhundi armed with wooden Sota and 6-7 unidentified persons to whom he could identify armed with baseball bat and wooden Sota came there. Rajpreet Singh @ Mana alias Channi raised Lalkara. Out of fear, he ran away. In the meanwhile, Labh Heera gave wooden Sota blow with the intention to kill on his head, which hit on the left side of head, Rajpreet Singh alias Mana alias Channi gave baseball bat blow with the intention to kill on his head, which hit on the left side of head, Kali Singh gave baseball bat blow on the back, which hit on the left side of chest, Krishan Singh gave baseball bat blow, which hit on the right thumb, Jagmeet Singh gave wooden Sota blow, which hit on the left shoulder, Bhundi gave wooden Sota blow, which hit on the right knee, Jagmeet Singh gave wooden Sota blow, which hit on the left knee, Kali Singh gave baseball bat blow which hit on the right arm, Rajpreet Singh alias Channi gave baseball bat blow which on left arm and unidentified persons also gave injuries on his person with their respective weapons. He raised Raula. Rajpreet Singh alias Channi snatched Rs.2,000/- from his pocket. While leaving the spot they threatened him that they have link in UP and to return back.”

3. Learned counsel for the petitioner in the asking for the relief (supra), submits that infact the matter has been compromised *inter-se* the parties for which, he draw the attention of this Court to Annexure P-2, which is an affidavit by sole injured-Yudhveer Singh.

4. At this stage, Mr. Kamal Narula, Advocate has caused appearance on behalf of the complainant-injured and submitted that he has “no objection” in case the relief of regular bail is granted to the present petitioner.

5. The learned State counsel has filed the custody certificate, which makes revelation that the petitioner has undergone incarceration of 1 month and 7 days as on today and he is not shown to have been

involved in any other criminal case. He further informs this Court on instructions imparted to him by the official concerned that the matter is still under investigation.

6. Keeping in view the allegations against the petitioner and the fact that the matter has been compromised between the parties and the petitioner has suffered incarceration of more than 1 month as on today and the case is still at the investigation stage, this Court deems it fit and appropriate to extend the benefit of regular bail to the petitioner. Therefore, the present petition is **allowed**.

7. The petitioner is ordered to be released on bail on furnishing of bail bonds and surety bonds to the satisfaction of concerned Chief Judicial Magistrate/trial Court/Duty Magistrate.

7. However, anything observed here-in-above shall have no effect on the merits of the case and is meant for deciding the present petition only.
