By way of present petition filed under Section 438 Cr.P.C,
the petitioner seek anticipatory bail in case FIR as under: -

2. Learned counsel for the petitioner submits that in compliance to the order dated 24.07.2024, the petitioner has joined the investigation.

3. During the course of hearing on 24.07.2024, following order has been passed: -

‘Heard.

Considering the submissions made by learned counsel for the petitioner as well as learned State counsel, without commenting on the merits of the case at this stage, the petitioner is hereby directed to join investigation within 07 days from today and co-operate in the same. In the event of the arrest of the petitioner, he shall be released on interim bail on his furnishing personal/surety bonds to the satisfaction of the Arresting Officer/Investigating Officer. He shall also abide by conditions as envisaged under Section 438(2) Cr.P.C.

4. Learned State counsel on instructions from SI Balbir Singh, informs the Court that the petitioner has joined the investigation and is neither required for further investigation nor for any custodial interrogation.

5. Keeping in view the above submissions made by learned State counsel and the fact that the petitioner had joined the investigation consequent to the order dated 24.07.2024 passed by this Court, interim bail granted vide order dated 24.07.2024 is hereby confirmed, subject to conditions as envisaged under Section 438(2) Cr.P.C. Further the petitioner is directed to join investigation as and when required in future by way of written notice for such purpose to be served by Investigating Officer of this case upon the petitioner; he will

not tamper with the evidence nor will influence the witnesses and will not leave the country without prior permission of the Court.
