Learned Senior counsel appearing for the petitioners argues that though the claim of the petitioners for the grant of benefit of minimum pay scale of the post on which the petitioners are working, as being given to the regular employees, has been declined by the respondents vide order dated 19.03.2024 (Annexure P/6) but now the case of the petitioners has been forwarded to the higher authorities for sympathetic consideration to grant the said benefit to the petitioners on the ground that it is only the State, which can pass an appropriate order keeping in view the bye-laws, which governs the respondent-society.

Learned Senior counsel appearing for the petitioners submits that as the petitioners are suffering since long, the respondents be directed that keeping in view the recommendations made vide impugned order for consideration of the claim of the petitioners by the higher authorities, the



said consideration be finalized in a time bound manner so that no further prejudice is caused to the petitioners.

Mr. Harish Nain, AAG, Haryana accepts notice on behalf of the respondent-State and Mr. Satya Pal Jain, Senior Advocate with Mr. Dhiraj Jain, Advocate accepts notice on behalf of the respondent-UOI.

Learned counsel for the respondents submits that appropriate decision in terms of the recommendations made by the authority concerned will be finalized in a time bound manner and in case, it is found feasible to accept the recommendations of the authority concerned qua the grant of benefit of minimum pay scale of the post on which the petitioners are working, the same will be extended to the petitioners otherwise, due reasons for not accepting the claim of the petitioners will be mentioned in the speaking order, which order will be passed within a period of 03 months from the date of receipt of copy of this order and the said speaking order will be conveyed to the petitioners as well.

Learned Senior counsel appearing for the petitioners submits that keeping in view the statement made by learned counsel for the respondents, present petition may kindly be disposed of having been not pressed any further at this stage.

Ordered accordingly.
