AWARD OF LOK ADALAT BENCH NO.4

On 09.08.2024, the following order was passed in this case.

“The matter has been discussed with the learned counsel for the appellants as well as the DAG, Haryana. Learned counsel for the appellants has filed a revised calculation sheet, according to which a sum of Rs.8,00,000/- is payable over and above the amount awarded by the Motor Accident Claims Tribunal, Patiala. A copy of the calculation sheet has been handed over to the learned DAG, Haryana, who promised to take up the matter with the concerned Administrative Department and seek instructions.

List the matter for hearing on 04.09.2024.”

On 04.09.2014 and 18.09.2024, direction was again issued to the respondent and the matter was adjourned to get instructions. On 23.10.2024, Mr.Rahul Jain, General Manager, Haryana Roadways, Jind came present and in his presence, the following order was passed:

“There is some dispute regarding total amount of compensation payable to the appellants.



Sh.Rahul Jain, General Manager, Haryana Roadways, Jind is present. He has shown us calculation sheet and in the same manner counsel for the appellants has also shown us calculation sheet and after going through both the documents, we are convinced that amount claimed by Mr.Mann is correct in view of judgment of Hon'ble the Apex Court in ***National Insurance Company Ltd. Vs. Pranay Sethi and others, 2017(4) RCR Civil 1009*** and other similar judgments which have been relied upon by the Constitutional Bench.

Counsel for the appellants has handed over the calculation sheet to Sh.Rahul Jain, General Manager, who states that he will send calculation sheet to the competent authority for approval and seeks an adjournment.

On request, adjourned to 13.12.2024.”

Today, at the time of hearing, Sh.Parveen Kumar, Clerk O/o General Manager, Haryana Roadways, Jind, has presented demand draft of Rs.7,92,643/- in the name of Harjeet Kaur-appellant No.1 (widow of the deceased) towards full and final settlement of the claimants in this appeal, which has been handed over to the counsel for the appellants. On the proposal sheet, her counsel has specifically stated that in case in future any dispute is raised by any other legal heir, she will indemnify the said legal heir. Counsel for the appellants states that this appeal be disposed of having been settled.
