Prayer in the present writ petition was for seeking directions to the respondents No.2 and 3 to remove 42 transportation vehicles (Trucks) bearing Registration Nos.HR61-C-2199, HR61-D-5131, HR61-D-4226, HR61-D- 7489, HR61-D-3865, HR61-C-5461, HR61-C-2366, HR61-C-4460, HR61-D- 4964, HR61-D-1280, HR61-D-6529, HR61-D-4994, HR61-D-4186, HR61-D-8373, HR61-D-4346, HR61-D-3854, HR61-D-1316, HR61-C-2677, HR61-C-4719, HR61-C-0450, HR61-D-7650, HR61-C-9591, HR61-D-7445, HR61-C- 9206, HR61-C-9134, HR61-D-6880, HR61-D-8004, HR61-C-9982, HR61-D-3748, HR61-D-9210, HR61-D-0951, HR61-D-4715, HR61-D-4745, HR61-D-1090, HR61-D-1324, HR61-D-0843, HR61-D-8424, HR61-D-5131, HR61-C- 2199, HR61-D-3602, HR61-D-8610 and a Toyota Fortuner Car Bearing Registration No.HR-61-D-0020 registered in the name of the petitioner-firm and its proprietor from the Black List Category of the respondent-Department.
