Challenge in the present petition is to the reference to notice/press release dated 06.09.2017 (Annexure P-1) and 12.09.2017 (Annexure P-2) whereby the name of the petitioners have been included in the list of disqualified directors qua entries at point No.620 (Nakul Dhawan) and 621 (Vikul Dhawan) for alleged violation of Section 164(2) (A) of the Companies Act.
