1. The petitioner in the instant petition filed under Section 482 Cr.P.C. is praying for quashing of the order dated 21.07.2023 (Annexure P-4) passed by the learned trial Court vide which bail granted to him in case No.NDPS/248/2022 arising out of FIR No.69 dated 19.03.2021 under Sections 22, 29, 61 of the Narcotic Drugs and Psychotropic Substances Act, 1985 registered at Police Station Maqbool Pura, District Amritsar, has been cancelled owing to his non-appearance in the Court and non-bailable warrants of his arrest have been issued.

2. Learned counsel for the petitioner submits that the petitioner had been granted the concession of regular bail vide order dated 18.06.2021 (Annexure P-2); challan was presented on 30.05.2022 in the absence of the petitioner; he was unaware of the proceedings in the case as he was suffering from severe muscular pain and was advised bed rest in the month of July 2023. Learned counsel further submits that the petitioner is ready to appear and join proceedings



before the learned trial Court. Hence, in the aforementioned facts and circumstances, the petitioner be protected till his appearance before the Court concerned and the Court be directed that his application, which he would be filing on his surrender, be decided expeditiously.

3. Notice of motion.

4. Mr. Navdeep Singh, Dy. Advocate General, Punjab who is present in Court, accepts notice on behalf of the State.

5. I have heard learned counsel for the parties and perused the relevant material on record.

6. In view of the limited prayer made by learned counsel appearing on behalf of the petitioner, the petition is disposed of with direction to the petitioner to appear and surrender before the learned trial Court within seven days from today. Till then, no coercive steps shall be taken against the petitioner, subject to payment of costs in the sum of ₹ 10,000/- which shall be deposited with the District Legal Services Authority, Amritsar.

7. However, it is made clear that in case the petitioner fails to surrender before the Court concerned within the above stipulated time period, this order shall be of no avail to him, thereafter. In case, on appearance and surrender, the petitioner moves an application for bail, the learned trial Court shall make earnest efforts to decide the same expeditiously in accordance with law.
