By way of present petition filed under Section 438 Cr.P.C, the
petitioner seeks anticipatory bail in case FIR (Annexure P-1) as under: -

FIR No.	Dated	Sections	Police Station
89	26.04.2024	406 and 420 IPC	Navi Baradari, District Police Commissionerate, Jalandhar.

2. Learned counsel for the petitioner submits that in compliance to
the order dated 31.05.2024, the petitioner has joined the investigation.

3. During the course of hearing on 31.05.2024, following order had
been passed: -

“2. It is, inter alia, contended by learned counsel for
the petitioner that the petitioner is innocent and has been
falsely implicated in this case by the complainant just to



exert pressure on the petitioner. He contends that as per the allegations levelled in the FIR all transactions and allegations are qua the daughter of the petitioner namely Aditi Goel. He contends that even the perusal of the FIR would reveal that the complainant had implicated the petitioner being the mother of Aditi Goyal and also her brother and sister. However, during the course of inquiry, before registration of the FIR, the brother and sister had been exonerated. He contends that perusal of the FIR would reveal that main grievance of the complainant is qua the daughter of the petitioner.

3. *Learned counsel for the petitioner further contends that the petitioner never indulged in any such transaction and she is not having any criminal antecedents and is ready to join investigation.*

4. *Notice of motion, returnable for 16.07.2024.*

5. *On the asking of the Court, Mr. Ankit Grewal, DAG, Punjab, present in Court, accepts notice on behalf of the State-respondent, and on instructions from HC Gurdial Singh, No. 2687, P.S. Near Vadala Chowk, Jalandhar, submits that the petitioner is not facing any other criminal case. He prays for time to file the status report/reply in the matter.*

6. *Mr. Charanpreet Singh, Advocate, has put in appearance on behalf of the complainant and files his power of attorney to assist learned State counsel in the matter. The same is taken on record.*

7. *Needful be done well before the date fixed with an advance copy to the counsel opposite.*

8. *In the meanwhile, the petitioner is hereby directed to join investigation within seven days from today and in the event of her arrest, she is ordered to be released on*



interim bail on her furnishing personal/surety bonds to the satisfaction of the Arresting Officer/Investigating Officer. She shall also abide by conditions as envisaged under Section 438(2) Cr.P.C.

4. Learned State counsel on instructions from ASI Sukhdeep Singh informs the Court that the petitioner has joined the investigation and is neither required for further investigation nor for any custodial interrogation.
5. Keeping in view the above submissions made by learned State counsel and the fact that the petitioner had joined the investigation consequent to the order dated 31.05.2024 passed by this Court, interim bail granted vide order dated 31.05.2024 is hereby confirmed, subject to conditions as envisaged under Section 438(2) Cr.P.C. Further the petitioner is directed to join investigation as and when required in future by way of written notice for such purpose to be served by Investigating Officer of this case upon the petitioner; she will not tamper with the evidence nor will influence the witnesses and will not leave the country without prior permission of the Court.
6. The petition stands allowed.
7. It is made clear that anything contained hereinabove shall not be construed to be an expression of opinion on the merits of the case.
