In the present petition, the petitioners are claiming benefit of salary for the suspension period from 09.09.1998 till 30.04.2002.

Learned Senior counsel appearing for the petitioners submits that keeping in view the reply filed by the respondents, all the allowance admissible to the petitioners for the suspension period has already been released but as per his instructions, a sum of Rs.2,52,447/- has not been released to the petitioners so far and hence, the respondents be directed to look into the said aspect and no other grievance survives in the present petition.

Learned State counsel submits that in case, any representation is received from the petitioners raising a plea that a sum of Rs.2,52,447/- has not been released to the petitioner so far as allowance of the suspension period, an appropriate speaking order will be passed within a period of 08 weeks from the date of receipt any such representation and in case, it is found feasible to grant the relief to the petitioners, the same will be extended to them otherwise, due reasons for not accepting the claim of the petitioners will be mentioned in the speaking order so passed, which will be conveyed to the petitioners.

Learned Senior counsel for the petitioners submits that keeping in view the statement of the learned counsel for the respondents, present
