The present bunch of petitions is pending since 2011 and the grievance being raised by the petitioners is only for fixing their seniority along with other selected candidates on the basis of the merit obtained by them so that the same could be taken into account for the grant of promotion to the post of Lecturer in Physical Education.

Learned counsel for the respondents submits that claim of the petitioners for the grant of promotion to the post of Lecturer in Physical Education keeping in view the merit obtained by them in the selection process will be considered and an appropriate speaking order will be passed within a period of 08 weeks from the date of receipt of copy of this order and in case it is found that the petitioners are eligible and any junior of the petitioners has already been granted the benefit of promotion to the post of Lecturer in Physical Education, claim of the petitioners will be considered for promotion from the said date only otherwise, due reasons for not accepting the claim of the petitioner will be mentioned in the speaking order so passed, which order will be conveyed to the petitioner for their information and necessary action.
