The petitioners namely Jasleen and Sukhpreet Singh have approached this Court under Article 226 of the Constitution of India for seeking protection of their lives and personal liberty from private respondents No.4 and 5.

The contention of the petitioners is that both are major, aged 18 years and 27 years respectively. In support thereof, copy of the Aadhaar Cards pertaining to the petitioners have been appended. The petitioners further contend that they have performed marriage against the wishes of their parents. The marriage of the petitioners was solemnized on 05.06.2024 at Gurudwara Dashmesh Pitah Patshahi Dasvin (Regd.), Village Singha Devi, Tehsil Kharar, District SAS Nagar (Mohali) as per Sikh rituals. A copy of marriage certificate (Annexure P-3) issued by

the aforesaid Gurudwara has also been appended. The petitioners apprehend threat to their lives and claim that there is a constant danger of being implicated in a false case.

Notice of motion restricted to respondents No.1 to 3 only.

Pursuant to supply of advance copy, Mr. Vishnav Gandhi, DAG, Punjab appears and accepts notice on behalf of respondents No.1 to 3.

Learned counsel for the petitioners states that a representation dated 05.06.2024 (Annexure P-5) has also been submitted by the petitioners to the respondent No.2- Senior Superintendent of Police, District Kapurthala.

Learned State counsel has no objection if appropriate direction for providing requisite protection to the petitioners is given.

Without examining the question of legality and validity of the marriage and expressing any opinion thereon, the petition is disposed of with the directions to respondent No.2- Senior Superintendent of Police, District Kapurthala to look into the grievances of the petitioners as set out in the petition and also expressed in the representation (Annexure P-5) and take appropriate action for protection of their lives and liberty as may be warranted by the circumstances.

However, it is clarified that in case any criminal case has been/is registered against the petitioners nothing in this order shall be

in respect thereof in accordance with law.

The Registry is directed to send a copy of this order along with copy of the petition and above-said representation to respondent No.2-Senior Superintendent of Police, District Kapurthala for requisite compliance.

The petition is disposed of.
