By way of present petition filed under Section 438 of the Code of Criminal Procedure, 1973, petitioner seeks anticipatory bail in case FIR (Annexure P-4) as under:

530	01.07.2023	406 and 420 of IPC	Barwala, District Hisar.

2. Learned counsel for the petitioner submits that in compliance to the order dated 01.08.2024 passed by this Court, the petitioner has already joined the investigation and as such prayed for confirming the interim bail granted vide order dated 01.08.2024 .
3. Learned State counsel, on instructions received from SI Bir Singh, intimates the Court that the petitioner has joined investigation and is neither required for further investigation nor for any custodial investigation.

4. During the course of hearing on 01.08.2024 , following order was passed:

“ Heard.

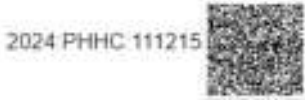
2. Reply dated 25.07.2024 in the form of an affidavit of Assistant Superintendent of Police, Hisar, District Hisar, has been filed. The same is taken on record. Copy thereof has been supplied to learned counsel for the petitioner.

3. Keeping in view the facts and circumstances of the case, it is deemed appropriate that the petitioner should join the investigation before deciding the petition on merits.

4. Accordingly, the petitioner is directed to join the investigation within seven days from today and in the event of his arrest, he is ordered to be released on interim bail on his furnishing personal/surety bonds to the satisfaction of the Arresting Officer/Investigating Officer. He shall also abide by conditions as envisaged under Section 438(2) Cr.P.C.

5. List on 29.08.2024. ”

5. Keeping in view the above submissions made by learned State counsel and the fact that the petitioner had joined the investigation consequent to the order dated 01.08.2024 passed by this Court, interim bail granted vide order dated 01.08.2024 is hereby confirmed, subject to conditions as envisaged under Section 482 (2) of BNSS, 2023. Further the petitioner is directed to join investigation as and when required in future by way of written notice for such purpose to be served by Investigating Officer of this case upon the petitioner; he will not tamper with the evidence nor will influence the witnesses and will not leave the country without prior permission of the Court.
