Instant petition under Section 482 Cr.PC has been preferred seeking directions to the official respondents No. 2 and 3 to get the proper and fair inquiry/investigation conducted in case FIR (Annexure P-1) registered against private respondents No. 5 to 7. Details of the FIR are as under: -

2. Heard.
3. It is submitted by learned counsel for the petitioner that the petitioner got the aforesaid FIR registered against the private respondents No. 5 to 7. He submitted that earlier the cancellation report



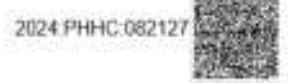
was submitted before the concerned Illaqa Magistrate which was sent back to the police for further investigation but the same is still pending decision. He further submitted that the petitioner had moved a representation dated 23.05.2024 (Annexure P-3) to the Senior Superintendent of Police, Faridkot, District Faridkot, in this regard, but no action has been taken on the said representation till date.

4. Learned counsel for the petitioner further contends that for the purpose of the present petition, the petitioner will be satisfied if appropriate directions are issued to respondent No. 3 to consider and dispose of the representation in accordance with the law in an expeditious manner.

5. Notice of motion to the official respondents.

6. On the asking of the Court, Mr. Siddharth Attri, AAG, Punjab, accepts notice on behalf of the State-respondents No. 1 to 4 and submits that the aforesaid representation will be considered and disposed of in accordance with the law.

7. In the circumstances of the case and without commenting on the merits of the case, the petition is disposed of with the direction to respondent No. 3-the Senior Superintendent of Police, Faridkot, District Faridkot, to consider the averments made in the representation dated 23.05.2024 (Annexure P-3), to dispose of the same expeditiously and to take action, as warranted, under the provisions of the law.
