DEEPAK GUPTA, J.

These four appeals have arisen out of common award dated 01.06.2009 passed by learned MACT, Sangrur. Though as many as seven claim petitions were filed arising out of same motor vehicular accident resulting into the common award dated 01.06.2009, but only the claimants of four of the claim petitions have approached this court by way of present appeals, seeking enhancement in compensation.

2. Motor vehicular accident had taken place on 21.02.2008. Claimants /appellants do not dispute the factum of the accident or any other finding of the Tribunal except to the extent of quantum of compensation. Even on the aspect of assessing the compensation amount in all the four appeals, the only plea raised by learned counsel for the claimants-appellants is that the compensation under the traditional heads of loss of estate and funeral expenses have not been awarded. Besides, no future prospectus were added in the total income of the deceased and the loss of consortium or filial consortium was not adequately granted.

3.1 Ld. counsel for the appellants-claimants has prayed for enhancing the compensation in the light of the law explained by Hon'ble Supreme Court in ***"Sarla Verma and others v. Delhi Transport Corporation and another"***, (2009) 6 Supreme Court Cases 121; ***"National Insurance Company Limited v. Pranay Sethi and others"*** 2017(4) RCR (Civil) 1009 and ***"Magma General Insurance Company Ltd. v. Nanu Ram @ Chuhru Ram and others"***, 2018(18) SCC 130 and ***"N. Jai Shree and others Vs. Chola Mandalum M.S. General Insurance Company Ltd."*** 2021 (4) RCR (Civil) 642.

3.2 Learned counsel for the Insurance Company has very fairly con-

ceded that compensation amount needs to be enhanced, as no compensation has been awarded under the traditional heads and also for the loss of consortium.

4. I have heard Id. counsel for both the parties.

5. Although the income of the four deceased in these four cases appear to have been taken on lesser side, but counsel for the claimants-appellants does not dispute the income of the deceased and has requested to enhance the compensation by taking the income as such, as has been taken into consideration by the Tribunal.

6.1 In **FAO-5293-2009 'Karamjit Kaur and others Vs. Nirbhaj Singh @ Bhola'**, deceased Jaswinder Singh was aged 29 years. There are five claimants. The Tribunal has assessed the total compensation to be ₹7,27,000/- by taking the monthly income of the deceased at ₹5000/- and taking the multiplier of 18.

6.2 In **FAO-5294-2009 'Mandeep Singh and others Vs. Nirbhaj Singh @ Bhola'** deceased Inderjit Kaur was aged 33 years. There are three claimants. The Tribunal has assessed the total compensation at ₹4,10,000/- by taking the monthly income of the deceased as ₹5000/- and applying the multiplier of 17.

6.3 In **FAO-5295-2009 'Bagga Singh and another Vs. Nirbhaj Singh @ Bhola'**, deceased Sinder Kaur was aged 34 years. There are two claimants. The Tribunal has assessed the total compensation of the amount of ₹3,67,000/- by taking the monthly income of the deceased as ₹3000/- and taking the multiplier to be 15.

6.4 In **FAO-5297-2009 'Harwinder Kaur and others Vs. Nirbhaj Singh @ Bhola'** deceased Supinder Singh was aged 32 years. There are three claimants. The Tribunal has assessed the total compensation at ₹5,51,000/- by taking the monthly income of the deceased as ₹4,000/- and applying the multiplier of 17.

7. Keeping in view the latest legal position as explained by Hon'ble

Supreme Court in **Sarla Verma; Pranay Sethi; and Nanu Ram @ Chuhru Ram (supra)**, the re-worked amount of compensation will be as under: -

8. The claimants-appellants of the respective claim petitions shall be entitled to the enhanced compensation along with interest @ 7.5% per an-

num from the date of filing of the claim petition till the realization. The compensation amount shall be paid in the same proportion as awarded by the Tribunal. It is further made clear that if during the pendency of these appeals, any of the claimants has expired, the compensation amount of his share shall be paid to his legal heirs.
