After arguing at some length and keeping in view the order passed by the Apex Court dated 23.08.2016 dismissing the SLP of the petitioners, counsel for the petitioners is not in a position to argue the matter. The order dated 23.08.2016 reads as under:-

Having considered the issues involved also consideration upon of the on behalf of on 01.04.2016, and additional affidavit filed the State of Haryana appeals insofar as appellant Nos.1,2 and 3 (Pawan Kumar Sharma, Subhash Chander and Ravinder Kumar) concerned are dismissed, whereas the appeals in respect of appellant No.4 (Thakur Prasad) are allowed, meaning thereby the acquisition notification insofar as appellant No.4 is concerned, is quashed and



the orders of the High Court are modified to the afore-said extent.

The appeals are disposed of in the above terms.

Learned counsel for the appellants, on instructions, seeks permission of this Court to withdraw this application with liberty to agitate the issues before appropriate forum.
