MAHABIR SINGH SINDHU, J.

Present petition has been filed under Article 226 of the Constitution for issuance of a writ in the nature of *habeas corpus* directing official respondents to produce victim namely Parveen alias Bhina Balkari lodged in District Jail, Jind in FIR No. 121 dated 17.07.2020, under Sections 302, 307, 148 read with Section 149 of IPC, registered at Police Station City Narwana.

(2) In response of notice of motion issued on 21.07.2023, status report by way of affidavit has already been filed by learned State counsel. Para Nos. 1 and 2 of the status report reads as under:-

“1. That, the petitioner Parveen @ Bhima S/o Ramesh R/o Gilod Kalan, District Rohtak was confined in District Jail, Jind from 30.10.2020 as under trial prisoner in case FIR No. 121 dated 17.07.2020 under Sections 302, 307, 148 read with Section 149 IPC & Sections 25, 54, 59 of Arms Act, 1959, Police Station City Narwana, Jind. As per jail records, the above aid under trial is also involved in 05 more case.

2. That, it is further submitted that the under trial prisoner is habitual offender and is also involved in 05 more cases details are as under:-
