Prayer in the present petition is for directing the respondents to release the due payment of Rs.12,50,297/- including security and difference of bituminous price qua the work of special repair of various ink roads falling in the jurisdiction of MC Tapa, Assembly Constituency Bhadaur under repair programme 2020-21 Phase-III (from compaction of earth work to open graded premix carpet with seal coat) Group No.1 executed by the petitioner , alongwith interest @ 12% p.a.

After arguing at some length, learned counsel for the petitioner submits that with regard to his grievance, the petitioner has submitted various representations followed by a representation (colly.) dated 02.07.2024 (Annexure P-3) but the respondents have neither paid the outstanding dues to the petitioner nor have they taken any action upon the said representation.

Notice of motion.

Learned counsel for the petitioner, however, contends that he would be satisfied at this stage, in case respondent No.4- The Executive Engineer, Construction Division, PWD, B & R Branch, Barnala is directed to consider and decide the representation (colly.) dated 02.07.2024 (Annexure P-3) served by the petitioner, by passing a speaking order in a time bound manner.

Learned State Counsel has no objection to the request made by learned counsel for the petitioner.

Accordingly, in view of the above; with the consent of the parties and without commenting anything on the merits of the case, the present petition is disposed of while directing respondent No.4 to consider and decide the representation (colly.) dated 02.07.2024 (Annexure P-3) by passing a reasoned and speaking order after affording an opportunity of hearing to the respective parties within a period of three months of the receipt of certified copy of this order.

Needless to mention that upon considering the said representation, if any amount is found due and payable to the petitioner, the same shall be disbursed in favour of the petitioner within a further period of three months.

Petition stands disposed of accordingly.
