1. By this common order, above mentioned seven writ petitions are being disposed of as all the writ petitions involve the same question of law on similar facts.

2. Learned counsel for the petitioners submits that while withdrawing the benefit of sports gradation certificate from the petitioners vide impugned orders, the respondents had not taken into account the letter dated 01.01.2016 (Annexure P/32) as well as letter dated 27.08.2021 (Annexure P/33) which have been issued by the Government of Haryana qua the grant of membership by the Indian Olympic Association to the Haryana State Throw ball Federation and hence, the petitioners intend to approach the respondents once again to reconsider their opinion qua the sports gradation certificate issued to the petitioners in view of those letters, which are just and proper.

3. Learned State counsel submits that in case any representation is

received from the petitioners within a period of 04 weeks from today for reviewing the decision of withdrawal of the sports gradation certificate of the petitioners on the basis of some documents, which might not have been taken into account earlier by the respondents, appropriate decision will be taken by the authorities concerned on the said representation within a period of 08 weeks from the date of receipt of such representation and in case it is found feasible to grant the relief sought, same will be extended, otherwise, due reasons will be mentioned in the speaking order.

4. Learned counsel for the petitioners submits that keeping in view the statement made by learned counsel for the respondents, present petitions may kindly be disposed of having been not pressed any further with liberty to the petitioners to approach the respondents by way of filing an appropriate representation.

5. Ordered accordingly.

6. At this stage, learned counsel for the petitioners submits that as the petitioners are already continuing in service under the interim order passed by this Court and the respondent-State has agreed to look into the grievance of the petitioners hence, till any fresh order is passed on the representation of the petitioners, petitioners be allowed to continue in service.

7. Learned State counsel submits that in case, any representation is received from the petitioners within a period of 04 weeks from today, till the same is decided by the authorities concerned as undertaken, the petitioners shall be allowed to continue in service so that no prejudice is caused to them.

8. Keeping in view the above, present petitions are disposed of in above terms.
