



Learned counsel for the petitioners submits that none of the petitioners has been declared as proclaimed offender and only the proceedings have been initiated against them.

He further requests for recording statement of petitioner No.5 through SPA as he is residing abroad.

In view of the above, the prayer made by counsel for the petitioners is allowed. Petitioner No.5 is allowed to record his statement through SPA through which he has filed the present petition, before the learned jurisdictional Magistrate.

Notice of motion for 27.09.2024.

At this stage, on the asking of the Court, Mr. Subhash Godara, Addl.A.G., Punjab accepts notice on behalf of respondent No.1-State and Mr. Meher Sachdev, Advocate accepts notice for respondents No.2 & 3 and files his vakalatnama and admits to the factum of compromise. Copy of the paper book be supplied to them during the course of day.

Service is complete.

In the meanwhile, the parties are directed to appear before the learned trial Court/Illaq Magistrate within two weeks from today or any other date convenient to the trial Court/Illaq Magistrate, to get their statements recorded regarding compromise and after recording their statements, learned trial Court/Illaq Magistrate is directed to send report regarding the genuineness of compromise and also to intimate whether any PO proceedings are pending against any of the party on or before the date fixed i.e. 27.09.2024.

A copy of the order be sent to learned trial Court/Illaq Magistrate through fax for compliance.”

3. In compliance of the aforesaid order, a report has been received from the concerned jurisdictional Court that the compromise between the parties is genuine and arrived at without any pressure or coercion from anyone.

4. In view of the compromise and the ratio of law laid down by the Hon'ble Supreme Court in ***Narinder Singh and others vs. State of Punjab and another, (2014) 6 SCC 466, Ramgopal and another Vs. State of Madhya Pradesh 2021 SCC OnLine SC 834*** and ***Shakuntala Sawhney (Mrs) Vs.***



Kaushalya (Mrs.) and others (1980) 1 SCC 63 and Full Bench of this Court in *Kulwinder Singh Vs. State of Punjab 2007 (3) RCR (Crl.) 1052*, this petition is allowed and FIR No.109 dated 26.11.2019 under Sections 420/406/498-A/120-B of IPC registered at Police Station Women Cell, Commissionerate of Police Jalandhar District Jalandhar (Annexure P-1) and all consequential proceedings arising out of the same are quashed, qua the petitioners.
