1. Prayer in the present petition is for directing the respondents to make the payment of Rs.1,46,37,759/- including security amount qua the works of providing and laying interlocking tiles in various streets of the City executed by the petitioner, alongwith interest @ 12% per annum.

2. After arguing at some length, learned counsel for the petitioner submits that with regard to his grievance, the petitioner has served a legal notice dated 21.06.2024 (Annexure P-3) but the respondents have neither paid the outstanding dues to the petitioner nor have they taken any action upon the said legal notice.

3. Notice of motion.

4. Ms. Niharika Sharma, AAG Punjab, accepts notice on behalf of the respondent-State and Mr. Saurav Verma, Advocate, accepts notice on behalf of respondent No.3 being its empanelled advocate. They both pray for some time to complete instructions and file response, if necessary.



5. Learned counsel for the petitioner, however, contends that he would be satisfied at this stage, in case respondent No.3- The Municipal Council, Talwandi Sabo, District Bathinda through its Executive Officer is directed to consider and decide the legal notice dated 21.06.2024 (Annexure P-3) served by the petitioner, by passing a speaking order in a time bound manner.
6. Learned Counsel for respondent No.3 has no objection to the request made by learned counsel for the petitioner.
7. Accordingly, in view of the above; with the consent of the parties and without commenting anything on the merits of the case, the present petition is disposed of while directing respondent No.3-The Municipal Council, Talwandi Sabo, District Bathinda through its Executive Officer to consider and decide the legal notice dated 21.06.2024 (Annexure P-3) by passing a reasoned and speaking order after affording an opportunity of hearing to the respective parties within a period of three months of the receipt of certified copy of this order.
8. Needless to mention that upon considering the said representation, if any amount is found due and payable to the petitioner, the same shall be disbursed in favour of the petitioner within a further period of three months.
9. Petition stands disposed of accordingly.
