1. Prayer in CWP-18547 & 18560-2024 is common to the extent that challenge has been raised to the notification dated 23.07.2024 (Annexure P-11) whereby Municipal Committee, Adampur, District Hisar has been abolished. Applications have now been filed in the said 2 writ petitions for withdrawal vide CM-17530-CWP-2024 in CWP-18547-2024 and CM-17435-CWP-2024 in CWP-18560-2024. Accordingly, the applications are allowed and the main writ petitions are dismissed as withdrawn.

2. In CWP-12724-2023, challenge was made to the notifications dated 19.03.2021 and 28.06.2021 (Annexures P-4 & P-9, respectively) whereby the area of Gram Panchayat, Adampur, Jawahar Nagar and Village Adampur were made part of Municipal Committee, Adampur.

3. Keeping in view the fact that the first 2 writ petitions are now sought to be withdrawn as the State itself has abolished Municipal Committee, Adampur, CWP-12724-2023 has been rendered infructuous and the same is disposed of, as such.

4. Keeping in view the above development, all interim orders stand vacated. All the applications including application(s) for impleading as party, are disposed of.
