The jurisdiction of this Court has been invoked under Section 482 Cr.P.C. for quashing of DDR No. 39 dated 08.09.2019 (Annexure P-1) under Sections 107/151 Cr.P.C. registered at P.S. 'B' Division, Urban, Sultanwind Gate, Amritsar.

Short reply by way of affidavit of Gupartap Singh Sahota, PPS, Assistant Commissioner of Police, East, Amritsar has been filed on behalf of learned State Counsel. The relevant paragraph of the reply is reproduced below :-

'4. That it is submitted that the proceedings of the above said Kalandara DDR No. 39 dated 08.09.2019 under Section 107/151 Cr.P.C., P.S. B-Division, Amritsar City, the Court of Deputy Commissioner of Police-cum-Executive Magistrate, Amritsar issued repeated notices, bailable warrants and warrants of arrest qua the present petitioner Chandan Kumar, but the same could not be served upon the present petitioner Chandan Kumar. Therefore, facing with the aforesaid situation, the Court of Deputy Commissioner of Police-cum-

*Executive Magistrate, Amritsar dropped the proceedings of the
aforementioned Kalandara DDR No. 39 dated 08.09.2019 under
Section 107/151 Cr.P.C., P.S. B-Division, Amritsar City and the
present petitioner Chandan Kumar was considered to be
discharged from these proceedings. The Zimny Order dated
07.09.2020 passed in this regard by the Court of Deputy
Commissioner of Police-cum- Executive Magistrate, Amritsar is
annexed herewith as Annexure R- 1/1 for the kind perusal of this
Hon'ble Court.'*

In view of the affidavit filed, the proceedings of DDR No.
39 dated 08.09.2019 under Section 107/151 Cr.P.C., P.S. B-Division,
Amritsar City has been dropped.

In light of the above, nothing survives in the present
petition. The petition is dismissed as having been rendered infructuous.
