1. The present petition has been filed *inter alia* with a prayer for issuance of directions to respondent Nos. 2 and 3 to protect life and liberty of the petitioners from the hands of respondent Nos. 4 to 7 and not to interfere in their personal lives.

2. It transpires from the petition that date of birth of petitioner No.1 in the petition has been mentioned as 05.11.2024 whereas as per secondary school examination certificate Annexure P-2, date of birth of petitioner No.1 has been mentioned as 05.11.2004. Faced with this, learned counsel for the petitioners submits that it is typographical error and date of birth of petitioner No.1 mentioned as 05.11.2024 be read as 05.11.2004. Ordered accordingly. Registry is directed to do the needful.

3. It has been averred that the date of birth of petitioner No.1 is 05.11.2004 while date of birth of petitioner No.2 is 07.09.2001. Copies of Aadhar Cards of petitioner Nos.1 & 2 to this effect are attached as Annexures P-1 and P-3 respectively and secondary school examination certificate is attached as Annexure P-2.

4. It has been submitted that the marriage of the petitioners was solemnized on 27.07.2024. The marriage certificate and photographs are

attached as Annexure P-4 and P-5. Respondent Nos. 4 to 7 had opposed to their marriage, as the petitioners had performed the marriage without their consent. The petitioners have submitted representation dated 01.08.2024 (Annexure P-6) to respondent No.2- Commissioner of Police, DAC Complex, Master Tara Singh Nagar, District Jalandhar seeking protection of their lives and liberty at the hands of respondent Nos. 4 to 7.

5. Notice of motion to respondent Nos.1 to 3.

6. On the asking of the Court, Ms. Manjot Kaur, AAG, Punjab accepts notice on behalf of respondent Nos.1 to 3.

7. Without expressing any opinion on the merits of the matter and in particular the legality of the alleged relationship, the present petition is disposed of with a direction to respondent No.2- Commissioner of Police, DAC Complex, Master Tara Singh Nagar, District Jalandhar to forthwith consider the aforesaid representation dated 01.08.2024 made on behalf of the petitioners and thereafter, take appropriate action on the same as is deemed fit in accordance with law to ensure the protection of life and liberty of the petitioners. Till then, protect the life and liberty of the petitioners. Respondent No.2 would pass necessary order without being influenced by any pleadings made in the petition.

8. It is made clear that this order shall not be taken to validate the alleged relationship between the petitioners or protect them from legal action for violation, if any, committed by them.
