All these writ petitions relate to the elections/membership of
Haryana Basketball Association.

Learned counsel for the respective parties are *ad idem* that they
would be satisfied in case, the competent authority under the Haryana
Registration and Regulation of Societies Act, 2012 ensures that the elections
to the governing body of the Society are held expeditiously and in a time
bound manner subject to any petition that may be filed in relation to the



membership of the Association.

Without going any further into the controversy and since no party has objection if the present petition is disposed of with a direction to the District Registrar, Firms and Societies, Hisar to ensure that timely election is held for the governing body of Haryana Basketball Association.

The present petition is disposed of with a direction to the District Registrar, Firms and Societies, Hisar to hold the election to the governing body of the Haryana Basketball Association in a time bound manner preferably within a period of 06 months from the date of receipt of certified copy of this order and subject to any dispute that may be raised with respect to the membership of the Association. Till such time that a duly elected governing body is appointed, the Administrator already appointed by this Court vide order dated 04.09.2023 in CWP-19599-2023, shall continue to discharge his functions as an Administrator exercising all powers of the governing body.

It is also informed that appeal No.1380 of 2023 has already been heard by the State Registrar of Societies, Haryana and the order is awaited. It is expected that the final order shall be pronounced expeditiously and without any further delay by the State Registrar of Societies, Haryana.

The present writ petitions are disposed of in above terms.

All other civil misc. applications, if any, stand disposed of.
