2 A short reply by way of affidavit of Vinod Kumar, Sub-Divisional Agriculture Officer Cheeka, Department of Agriculture and Farmer's Welfare, Kaithal, has been filed in the Court today. A copy of the same has been supplied to the learned counsel appearing for the petitioners.

3 Specific averments made in paras No.6 and 7 of the reply are extracted as under:-

“6. That in compliance of the order dated 14.11.2023 in CWP 1248 of 2023 passed by this Hon'ble court the petitioners got registered their crop on the portal of MFMB for Rabi season-2023. It submitted that due some technical fault/issues the OTP did not generate in the kharif season-2024 from the said portal and one-time password could not provide by the officials to the present petitioners for Kharif season 2024.

7. That it pertinent to mention here that the portal of MFMB is open now and all the petitioners have registered their crop on the portal of Meri Fasal Mera Byora for kharif-season 2024. It is submitted that on 19.09.2024 vide letter memo no. 7309- 12 was issued from the office of respondent Deputy Director of Agriculture and Farmers Welfares Department Kaithal to all the petitioners regarding registration of their crop on the above said portal and remaining farmers if any, can get their crop registered on the above said portal. Copy of letter dated 19.09.2024 is annexed as Annexure R-1.”

4 Since the prayer made in the present writ petition was for directing the respondents to open the Portal of the Website 'Meri Fasal

Mera Byora, and also to provide the ‘One Time Password’ to the petitioners to enable them to sell their crops through the Government Portal and the needful having already been done, the present petition has been rendered infructuous.
