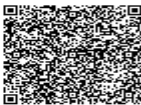

The present petition has been filed under Article 226/227 of the Constitution of India for issuance of direction in the nature of Habeas Corpus for appointment of Warrant Officer to release the detenue, i.e. Kehar Singh s/o Malook Singh, aged 94 years from illegal confinement of respondents No.4 and 5, as he has been kept in illegal confinement since 31.07.2024 and petitioner, who is son of detenue, is not being allowed to meet his father as respondents No.4 and 5 alongwith their associates/Nihangs have confined the detenue, i.e. Kehar Singh in his own house by transferring his house and agricultural land in their name and now not allowing anyone to meet him. It is further prayed to initiate legal action against respondents No.4 and 5 for illegally confining the detenue since 31.07.2024 and not allowing the petitioner to meet him as he is being confined in his own house, which is guarded by Nihangs of respondents No.4 and 5 and he is not being allowed to meet anyone.

2. Status report by way of an affidavit dated 21.08.2024 of Sh.



District Hoshiarpur was filed wherein the following has been stated :-

“4. That it is submitted that the petitioner alongwith his relatives came to Police Station Garhshankar District Hoshiarpur on 16.8.2024 Then SI Baljinder SHO PS Garhshankar alongwith police party took the petitioner and his relatives to the house of the father Kehar Singh at village Chahalpur PS Garshankar District Hoshiarpur vide DDR No. 16 dated 16.8.2024 where Kehar Singh father of the petitioner and Inderjit Kaur sister of the petitioner were present in the house and they were not detained by anybody. Then the petitioner met his father Kehar Singh and sister Inderjit Kaur and the Videography of the meeting of the petitioner with his father Kehar Singh and sister Inderjit Kaur was prepared by the Police of PS Garshankar and after meeting of the petitioner with his father Kehar Singh and sister Inderjit Kaur, the police of PS Garhshankar arrived back alongwith petitioner and his relatives at PS Garshankar, District Hoshiarpur on 16.8.2024 vide DDR No.20 dated 16.8.024.”

3. In view of the above, the present petition has been rendered infructuous and is disposed of as such.
