KULDEEP TIWARI, J.(Oral)

1. Through the instant petition, prayer is made for issuing a *mandamus* upon the official respondents no.2 and 3 to protect the life, liberty and property of the present petitioners, at the hands of respondents no.4 to 7.

2. Mr. Shadab Ahmad, Advocate, has caused appearance on behalf of respondent no.7, through a validly executed power of attorney in his favour. The same is taken on record.

3. This Court vide order dated 21.08.2024, passed the following order:-

“1. Through the instant petition, the petitioners seek issuance of directions upon the respondents No.2 and 3, to ensure protection of their lives and liberty, at the hands of respondents No.4 to 7.

2. Perusal of the instant petition reveals that, the petitioner No.1, during subsistence of her marriage with respondent No.4, decided to walk out of her matrimonial

relationship and now, she has been living in 'live-in relationship' with the petitioner No.2.

3. Notice of motion.

4. Mr. Pardeep Bajaj, D.A.G., Punjab, waives service of notice on behalf of the respondents No.1 to 3, and, he is directed to, through the respondent No.3- S.H.O. concerned, file a status report, detailing therein whether the threat perception, as alleged by the petitioners, genuinely exists or the same is based upon mere assumptions and presumptions.

5. Subject to requisite process fee being filed by the learned counsel for the petitioners, notices be issued to the respondents No.4 to 7.

6. List on 23.09.2024, for awaiting the status report."

4. In pursuance of the aforesaid direction, a status report, dated 21.09.2024, by way of an affidavit of SI Harpal Singh, SHO, Police Station Beas, Amritsar (Rural), has been filed, by the learned State counsel today in Court, which is taken on record, with a copy thereof supplied to learned counsel for the petitioners.

5. As per the aforesaid status report, the statements of the petitioners were recorded, in which they informed the inquiry officer that they do not have any threat perceptions as of now, and they do not want any security.

6. In view of the aforesaid specific statement suffered by the petitioners before the inquiry officer, no further direction is required to be passed by this Court, therefore, the instant petition is ordered to be closed.

7. **Disposed of** accordingly.

8. All pending application(s), if any, also stand **disposed of** accordingly.
