Prayer in the present petition is for issuance of writ in the nature of certiorari for quashing the order dated 12.02.2008 passed by respondent No.4 (Annexure P-2), Order dated 18.12.2008 passed by respondent No.3 (Annexure P-3), order dated 26.05.2010 passed by respondent No.2 (Annexure P-4) and order dated 13.07.2017 passed by respondent No.1 (Annexure P-7) whereby three Mutation Nos.1572, 2723 & 2724 pertaining to Villages Maruli Brahmna and Bassi Daulat Khan, Tehsil and District Hoshiarpur have been sanctioned on the basis of sale deed dated 22.03.2006 without taking into consideration the facts and circumstances and the manner in which on the fraudulent basis, the Sale deeds were executed on the basis of power of attorney, which is already assailed before the Civil Court, which is apparent from the facts and circumstances, which are being set out in the Civil Writ Petition. Further

prayer has been made to restrain the private respondents from changing the nature of the property and to alienate the same on the basis of Mutation Nos.1572, 2723 & 2724 in any manner.

Reply by way of affidavit of Sh. Gursevak Chand, Tehsildar-cum-Assistant Collector Ist Grade, Hoshiarpur has been filed on behalf of respondents No.4 , in the Court today. Same is taken on record.

Learned State counsel on instructions from Mr. Amandeep Singh, Patwari, Hoshiarpur, has submitted that the grievance of the petitioner(s) has been redressed as the Mutation prayed for has already been entered and the present petition has become infructuous.

Learned counsel for the petitioner has also affirmed the submissions made by learned State counsel.

In view of the above, the present petition is disposed of as having been rendered infructuous.
