Suraksha Sanhita 2023 (BNSS) has been preferred seeking directions to
the official respondents for transferring the investigation to some other
District in case FIR (Annexure P-1) as under: -

3. It is submitted by learned counsel for the petitioner that the petitioner happens to be the complainant of the aforesaid FIR registered way back on 07.07.2024 but no action has been taken by the police. Aggrieved by the same, the petitioner has moved a representation to the Inspector General of Police, Rewari Range, Haryana, on 05.08.2024, but the said representation is still pending decision.

4. Learned counsel for the petitioner further contends that for the purpose of the present petition, the petitioner will be satisfied if appropriate directions are issued to respondent No. 3 to consider and dispose of the aforesaid representation in accordance with the law in an expeditious manner.

5. Notice of motion to the official respondents.

6. On the asking of the Court, Ms. Gaganpreet Kaur, DAG, Haryana, who is present in Court, accepts notice on behalf of the official respondents and submits that the aforesaid representation shall be considered and disposed of in accordance with the law expeditiously.

7. Keeping in view the facts and circumstances of the case and without commenting on the merits of the case, the petition is disposed of with the direction to respondent No.3-Inspector General of Police, Rewari Range, Haryana, to consider the averments made in the representation dated 05.08.2024 (Annexure P-5), to dispose of the same



expeditiously and to take action, as warranted, under the provisions of the law.

8. Decision so taken be conveyed to the petitioner.
