The instant petition has been instituted under Articles 226/227 of the Constitution of India, 1950 seeking issuance of a writ in the nature of Mandamus directing the respondents to release the payment of all the three bills submitted by the petitioner firm to the respondent No.3- Municipal Corporation, Ambala, alongwith interest @ 18% per annum.

Learned counsel for the petitioner submits that with regard to the grievance, petitioner-firm has served various representations to the respondent-authorities but no action has been taken by the respondent-authorities. However, a latest representation dated 27.10.2023 (Annexure P-19) has been sent by the petitioner-Contractor to the respondent-authorities but due amount has not been released to the petitioner.

Mr. Vivek Saini, Advocate appears and accepts notice on behalf of respondent No. 3-Municipal Corporation, Ambala.

Learned counsel for the petitioner, however, submits that at this juncture, he would be satisfied if respondent No.3-Municipal Corporation, Ambala through its Commissioner is directed to consider and decide the representation dated 27.10.2023 (Annexure P-19) in a time bound manner.

Learned Counsel appearing on behalf of the respondents do not oppose the prayer made by learned counsel for the petitioner.

Accordingly, in view of the above, with the consent of the parties and without commenting anything on the merits of the case, the present petition is disposed of while directing respondent No.3-Municipal Corporation, Ambala through its Commissioner to consider and decide the representation dated 27.10.2023 (Annexure P-19) by passing a reasoned and speaking order after affording an opportunity of hearing to the respective parties within a period of three months from the date of receipt of certified copy of this order.

Needless to mention that upon considering the said representation, if any amount is found due and payable to the petitioner, the same shall be disbursed in his favour within a further period of three months.

Petition stands disposed of accordingly.
