The instant petition has been instituted under Articles 226/227 of the Constitution of India, 1950 seeking issuance of a writ in the nature of Mandamus directing the respondents to release the payment of Rs. 90,04,497/- qua the works of providing service of door to door collection of garbage, segregation of garbage from 01.12.2021 to 30.04.2022, executed by the petitioner, alongwith interest @ 18% p.a.

Learned counsel for the petitioner submits that with regard to his grievance, he has served Legal Notice dated 19.07.2024 (Annexure P-7) to the respondent-authorities but no action has been taken by the respondent-department.

Mr. Vivek Saini, Advocate appears and accepts notice on behalf of respondents No. 4 and 5-Municipal Council, Hodal (Palwal).

Learned counsel for the petitioner, however, submits that at this juncture, he would be satisfied if respondent No.5-the Executive Officer, Municipal Council, Hodal (Palwal) is directed to consider and decide the Legal Notice dated 19.07.2024 (Annexure P-7) in a time bound manner.

Learned Counsel appearing on behalf of the respondents do not oppose the prayer made by learned counsel for the petitioner.

Accordingly, in view of the above, with the consent of the parties and without commenting anything on the merits of the case, the present petition is disposed of while directing respondent No.5-the Executive Officer, Municipal Council, Hodal (Palwal) to consider and decide the Legal Notice dated 19.07.2024 (Annexure P-7) by passing a reasoned and speaking order after affording an opportunity of hearing to the respective parties within a period of three months from the date of receipt of certified copy of this order.

Needless to mention that upon considering the said Legal Notice, if any amount is found due and payable to the petitioner, the same shall be disbursed in his favour within a further period of three months.

Petition stands disposed of accordingly.
