1. Learned counsel for the rival parties are at consensus that the issue involved in the present appeals has rendered infructuous.

It is contended that the present appeals were against an interlocutory order passed by the learned Single Judge on 25.10.2017 in CM-10198-CWP-2017 in/and CWP-3904-2015, CWP Nos. 3226, 3291, 3293, 3965, 3966, 20872, 3893, 3886, 21400, 21448-2015 and 26384-2016 and since the said writ petitions have been decided by another learned Single Judge vide final order dated 08.02.2024, the present appeals have become infructuous and may be dismissed as such.
