1. As common issues are involved in the above captioned applications, the captioned applications are hereby disposed of by this common order. The facts for the sake of brevity and convenience are borrowed from *ARB-421-2024*.

2. The applicant was allotted work vide purchase order dated 21.06.2019 (Annexure P-1) by the respondent. There is an arbitration clause in the aforesaid purchase order. The allotment of work, arbitration clause in the purchase order and demand notice is not disputed.

3. Conditions to invoke power conferred by Section 11(6) of 1996 Act stand satisfied, thus, I hereby appoint a sole Arbitrator to adjudicate the dispute between the parties.

4. Mr. Justice M.S. Sullar, Retired Judge of this Court, residing at House No.220, Sector 25, Panchkula, Haryana, Mobile No.9780008105 is hereby appointed as a Sole Arbitrator to adjudicate the dispute between the parties, subject to compliance of statutory requirements. The learned Arbitrator is requested to comply with mandate of Section 12 of 1996 Act before proceeding further.

5. Parties are directed to appear before the learned Arbitrator on date, time and place to be fixed by the Arbitrator at his convenience.

6. The Arbitrator shall be paid fee in accordance with the Fourth Schedule of the Act, as amended.

7. The Arbitrator is requested to complete the proceedings as per time limit specified under Section 29-A of the Act.

8. Needless to mention, parties would be at liberty to raise all the claims/defences/counter claims/pleas before the Arbitrator. Any observation made hereinabove will not be binding on the learned Arbitrator.
