PANKAJ JAIN, J.(ORAL)

By way of present petition, the petitioners are seeking quashing of cross case bearing G.D.No.21 dated 30.03.2023 (Annexure P-2) registered under Sections 323, 324, 326 and 34 IPC, Police Station Sekhwan, Police District Batala, District Gurdaspur registered in FIR No. 28 dated 24.03.2023 (Annexure P-1) registered under Sections 323, 324, 325, 326, 148 and 149 IPC at Police Station Sekhwan, Police District Batala, District Gurdaspur and all consequent proceedings arising therefrom on the basis of compromise.

On 30.10.2023, the following order was passed:

“Present is a version and cross-version case. Petition bearing CRM-M-47858-2023 has been moved invoking jurisdiction of this Court under Section 482 Cr.P.C by the petitioners seeking quashing of cross-case bearing G.D. No.21 dated 30.03.2023 registered under Sections 323, 324, 326, 34

IPC arising out of FIR No.28 dated 24.03.2023 registered for offences punishable under Sections 323, 324, 325, 326, 148, 149 IPC at Police Station Sekhwan, Police District Batala, District Gurdaspur along with all subsequent proceedings arising therefrom. Petition bearing CRM- M-50158-2023 has been moved invoking jurisdiction of this Court under Section 482 Cr.P.C by the petitioners seeking quashing of FIR No.28 dated 24.03.2023 registered for offences punishable under Sections 323, 324, 325, 326, 148, 149 IPC at Police Station Sekhwan, Police District Batala, District Gurdaspur along with all subsequent proceedings arising therefrom.

Learned counsel for the petitioner(s) contend that the matter already stands compromised vide compromise dated 14/15.09.2023.

Notice of motion for 14.02.2024.

On the asking of the Court, Mr. Tarun Aggarwal, Sr. DAG, Punjab accepts notice on behalf of respondent No.1-State. Mr. Azam Khan, Advocate for Mr. Ritesh Pandey, Advocate appears and accepts notice on behalf of respondent No.2 in CRM-M-47858-2023 and Mr. Komalpreet Singh, Advocate for Mr. Amandeep Singh Manaise, Advocate appears and accepts notice on behalf of respondent No.2 in CRM-M-50158-2023 and both admit the fact of there being a compromise between the parties.

In view of the above, the parties are directed to appear before learned Duty Magistrate/Illaq Magistrate on 22.11.2023. On their doing so, the learned Duty Magistrate/Illaq Magistrate shall record their statements and furnish its report to this Court by the next date of hearing on the following aspects:-

- 1. Number of persons arrayed as accused in the FIR.*
- 2. Whether any accused is proclaimed offender?*
- 3. Whether the compromise is genuine, voluntary and without any coercion or undue influence?*
- 4. Whether the accused persons are involved in any other case or not?*
- 5. The Court is also directed to record the statement of the Investigating Officer as to how victims/complainants are there in the FIR.*

A copy of the report be also sent to the Registrar Judicial of this Court.

Needless to say that in case for any reason the statements are not recorded on the aforesaid date, the learned Duty Magistrate/Illaq Magistrate Court shall be at liberty to call the parties on any other date but not later than a week thereafter.

A photocopy of this order be placed on file of connected case.”

3 Pursuant to the aforesaid order, report dated 16.01.2024 from Judicial Magistrate 1st Class, Batala has been received, which is taken on record. As per the report, the Trial Court has recorded as follows:-

“After recording of statements of parties and IO, the requisite point wise report is prepared as under:-

1. As per the statement of I.O as well as the parties there are three persons who are arraigned as accused in the present case.

2. As per the statement of I.O neither of the accused persons are declared Proclaimed offenders in this case.

3. After considering the statements of the parties as well as the statement of I.O, this Court is of the view that the compromise between the parties in the present case is genuine, voluntary and without any coercion or undue influence.

4. As per the statement of I.O, no other proceeding is pending against the accused persons.

5. As per the statement of I.O only one victim/complainant is there in the present FIR namely Kanwaljeet Singh S/o Lakhbir Singh, resident of Village Daulatpur, Tehsil Batala, District Gurdaspur.”

4 Learned counsel for respondents No.2 admits the fact of parties having compromised and states that he has no objection in case the FIR and all proceedings subsequent thereto against the petitioners is quashed.

5 Similarly, learned State counsel has stated no objection in case the FIR is quashed based upon the compromise (Annexure P-3).

6 I have heard learned Counsel for the parties and have carefully gone through the records of the case.

7 This Court and Apex Court has repeatedly dealt with the issue of exercise of jurisdiction under Section 482 of the Code to quash proceeding in non-compoundable offences in the cases of ***Gian Singh vs. State of Punjab and another, 2012(10) SCC 303, State of Madhya Pradesh vs. Laxmi Narayan and others (2019) 5 SCC 688, Kulwinder Singh & others vs. State of Punjab & another, 2007 (3) RCR (Criminal) 1052 and Ram Gopal and another vs. State of Madhya Pradesh, 2021(4)***

R.C.R. (Criminal) 322 (Criminal Appeal No.1489 of 2012 decided on 29th of September, 2021). The proposition of law that emerges from the aforesaid decisions rendered by Apex Court and this Court is :

(a) Power u/s 482 Cr.P.C. vested with this Court is much wider and is unaffected by Section 320 of the Code.

(b) However, wider the power greater the caution.

(c) The underlining principle while exercising such power is that it can be invoked to quash the proceedings recognizing compromise between the parties in the matters which are overwhelmingly and predominantly of civil character like commercial transactions or arising out of matrimonial relationship or family disputes.

(d) The said power is not to be exercised in the prosecutions involving heinous and serious offences of mental depravity or offences like murder, rape, dacoity etc. as such offences are not private in nature and have a serious impact on society.

(e) Section 482 Cr.P.C. casts duty upon the High Court to advance interest of justice as well. It is in recognition of this duty casted upon the High Court, that Apex Court held that the High Court would not refuse to quash FIR under Section 307 merely because FIR finds mention thereof. High Court can assess nature of injuries sustained, whether such injuries inflicted on vital/delicate parts of the body/nature of weapons used etc.

(f) Such exercise at the hands of High Court would be permissible only after the evidence is collected after investigation and chargesheet is filed/charges framed during the trial. Such exercise cannot be carried out while the matter is still under investigation.

(g) While quashing FIR in non-compoundable offences even which are of private in nature, High Court is required to consider antecedents of the accused, conduct of the accused and whether he was absconding or whether he has managed the complainant to enter into a compromise.

8. Thus, keeping in view the aforesaid facts and circumstances, this Court is of the considered opinion that it is a fit case to exercise jurisdiction vested u/s 482 Cr.P.C. to quash the FIR as :-

*(i) The present matter does not fall within the exceptions as carved out in **Laxmi Narayan's** case (supra) i.e. heinous offence.*

(ii) The offences alleged are of private nature.

- (iii) *The parties have compromised.*
- (iv) *As per the report received the compromise is said to be voluntary in its nature.*
- (v) *Complainant/victim is reported to have entered into compromise on his own volition.*

9. Consequently, the petition is allowed. Cross case bearing G.D.No.21 dated 30.03.2023 (Annexure P-2) registered under Sections 323, 324, 326 and 34 IPC, Police Station Sekhwan, Police District Batala, District Gurdaspur registered in FIR No. 28 dated 24.03.2023 (Annexure P-1) registered under Sections 323, 324, 325, 326, 148 and 149 IPC at Police Station Sekhwan, Police District Batala, District Gurdaspur and all proceedings arising therefrom, are, hereby, quashed qua the petitioners.
