MANJARI NEHRU KAUL, J. (ORAL)

1. The petitioner in the instant petition filed under Section 528 of BNSS is praying for quashing of the order dated 06.05.2024 (Annexure P-2) passed by the learned trial Court vide which bail granted to him was cancelled, along with order dated 29.08.2024 (Annexure P-5) vide which PO proceedings have been initiated in case FIR No.90 dated 16.09.2020 under Sections 379-B, 395, 427 of the IPC registered at Police Station City Banga, District SBS Nagar, owing to his non-appearance in the Court.
2. Learned counsel for the petitioner submits that the petitioner had been regularly appearing before the Court concerned and it was only on 06.05.2024 that he was unable to put in an appearance on account of his illness. Learned counsel further submits that the petitioner is ready to appear and join proceedings before the learned trial Court. Hence, in the aforementioned facts and circumstances, the petitioner be protected till his appearance before the Court concerned and the Court be directed that



his application, which he would be filing on his surrender, be decided expeditiously.

3. Notice of motion.

4. Mr. Shiva Khurmi, Asst. Advocate General, Punjab who is present in Court, accepts notice on behalf of the State.

5. I have heard learned counsel for the parties and perused the relevant material on record.

6. In view of the limited prayer made by learned counsel appearing on behalf of the petitioner, the petition is disposed of with direction to the petitioner to appear and surrender before the learned trial Court within seven days from today. Till then, no coercive steps shall be taken against the petitioner, subject to payment of costs in the sum of ₹20,000/- which shall be deposited with the District Legal Services Authority, SBS Nagar.

7. However, it is made clear that in case the petitioner fails to surrender before the Court concerned within the above stipulated time period, this order shall be of no avail to him, thereafter. In case, on appearance and surrender, the petitioner moves an application for bail, the learned trial Court shall make earnest efforts to decide the same expeditiously in accordance with law.
