Petitioner has filed the present writ petition under Articles 226/227 of the Constitution of India, *inter alia*, seeking a writ in the nature of Certiorari for setting aside the impugned Final Result dated 27.07.2024 (Annexure P-7) for the posts of TGT Sanskrit (ROH and MEWAT) (Group- C Services) against Advertisement No.2/2023 dated 21.02.2023 (Annexure P-1) declared by respondent No.3 (Haryana Staff Selection Commission).

2. On the last date of hearing, i.e. 20.09.2024, the following order was passed by a Co-ordinate Bench of this Court:-

“Learned State counsel, at the outset, contends that after rectification of the petitioner’s result the Commission is in the process of recommending her for appointment, and seeks a short adjournment on that account.

Adjourned to 14.10.2024.”

3. Learned State counsel has handed over a photocopy of letter

dated 10.10.2024 in Court today, which is taken on record. A copy thereof has also been handed over to learned counsel for the petitioner in Court today itself. The relevant extract of letter dated 10.10.2024, would read as under:

“I am directed to invite your kind attention on the subject cited above and to say that in compliance of order dated 20.09.2024 passed in CWP No. 24060 of 2024 titled as Archana Kumari Vs. State of Haryana and others, the Commission has decided to recommend the name of the petitioner in BCB Women category. The Petitioner namely Archana Kumari bearing Roll No. 2231001511, has scored total 67.45 marks (DOB 04.11.1985), whereas, the last selected candidate of BCB Women category scored 67.45 marks (DOB 14.10.1994) (TGT Sanskrit ROH). The Petitioner has scored equal marks as the last selected candidate, and the petitioner is older in age than the last selected candidate in BCB Women category. As per law of merit and overall performance under the criteria, she falls in selection zone and selected at merit 492-A in BCB Women category and recommended for the post of TGT Sanskrit (ROH), against the Advt. No. 02/2023, Cat. No. 6.

2. The selected candidate has not been medically examined and no special enquiry in her antecedent has been made. The document pertaining to her Essential Qualification, Age, Caste/Category, Universities, and Experience as claimed by him in the application form may please be got checked/verified from the issuing authorities, before she is allowed to join her duty. A copy of the appointment letter issued to the candidate may also be endorsed to the Commission.

3. The recommendation alongwith original application forms with enclosures of Archana Kumari D/o Sh. Satyavir Singh bearing Roll No. 2231001511 for the posts of TGT Sanskrit (ROH) against Advt. 02/2023, Cat. No. 6, resident of City Zainabad, Tehsil Dahina, Distt Rewari- 123411 is sent herewith for further necessary action at your end.”

Learned counsel appearing on behalf of petitioner, after going

through the aforesaid letter dated 10.10.2024, submits that she does not intend to press the present writ petition any further, at this stage.

5. Keeping in view the aforesaid submissions made by counsel for the parties, present writ petition is disposed of, accordingly.
