**VINOD S. BHARDWAJ, J. (Oral)**

Even though these three writ petitions have been filed espousing concern with respect to the affairs of the Haryana Football Association, however, learned counsel appearing on behalf of the respective respondent(s) contend that their concern at this juncture is about a fair elections of the governing body. They contend that they would take recourse to their other remaining grievances/disputes before the competent authority under the provisions of the Haryana Registration and Regulation of Societies Act, 2012 and that at this juncture they would be satisfied in case the election of the governing body of the Haryana Football Association is undertaken in the presence of an Observer appointed by this Court.

Learned counsel for the respondent-Haryana Football Association has no objection to the same.

The present batch of writ petitions is thus **disposed of** at this juncture with liberty to the petitioners to take recourse to their alternative remedies for their respective grievances in a manner known to law and before the appropriate authority under the Haryana Registration and Regulation of Societies Act, 2012 by appointing Ms. Aarushi Garg, Advocate, PH-4567/2020 (Mobile No. 79863-13709) as an Observer to over-see the election of the governing body of the Haryana Football Association to be held on 23.08.2024 from 10.00A.M. to 4.00 P.M. at Smart View Hotel and Resorts Pvt. Ltd., Damdama Road, Sohna, Gurugram and she shall furnish her report before this Court with a copy to the learned

counsel for the respective parties.

The fee admissible to the Observer i.e. Rs.55,000/- shall be paid by the petitioners during the course of the day.

The parties shall, however, be at liberty to take appropriate steps in the event any cause of action arises.

Copy of the order(s) be given to the learned counsel for the respective parties as well as to the Observer appointed under the signatures of the Court Secretary for necessary compliance.

All the three writ petitions are accordingly disposed of.
