Notice in the application.

Advocate, has appeared on behalf of the non-applicant/respondent in this
case and they accept the notice and submit that they have no objection in
allowing the present application.

Keeping in view the afore-discussed facts and circumstances, all the above-named applicants are allowed to be impleaded as the Legal Representatives of the appellant in the main appeal, subject to all the just exceptions and for the purpose of the adjudication of the main appeal only. Amended Memo of Parties is already available on the file and the same is taken on the record.

The application in hand stands allowed accordingly.

CM No.275-C of 2024

This application has been moved on behalf of the applicants-LRs of the appellant for seeking permission to place the copy of the Compromise-Deed on the record, as Annexure A-2, with the further prayer to dispose of the main appeal accordingly.
