Learned counsel for the appellant prays to withdraw the present appeal in view of circular issued by the Central Board of Indirect Taxes and Customs, Government of India dated 06.08.2024, whereby in exercise of powers under Section 35R of the Central Excise Act, 1944 made applicable to the Service Tax vide Section 83 of the Finance Act, 1994, the Central Board of Indirect Taxes and Customs has fixed the minimum monetary limits of Rs.2 Crore for High Courts for the purpose of filing of appeals against the order of the CESTAT.
